

MINUTES OF THE REGULAR MEETING  
OF THE  
WEST MONROE CITY COUNCIL

January 14, 2014

There was a regular meeting of the West Monroe City Council held on Tuesday, January 14, 2014, at 7:00 p.m. in the Council Chambers of the West Monroe City Hall.

Those present were Mayor Dave Norris, Aldermen James Brian, James Bennett and Fred Ragland, Alderwomen Staci Albritton-Mitchell and Alice Pearson.

The invocation was offered by Jerry Edmondson.

There was a motion by Mrs. Pearson, seconded by Mr. Brian and unanimously carried to approve the minutes of the December 10, 2013 Special Council Meeting.

There was a motion by Mrs. Pearson, seconded by Mr. Bennett and unanimously carried to approve payment of the December 2013 billings, subject to audit by the Finance Committee.

There was a motion by Mrs. Albritton-Mitchell, seconded by Mrs. Pearson and unanimously carried to approve an ordinance to amend, and thereafter to affirm, Ordinance No. 3675 and Ordinance No. 4157, revoking an alleyway between 5<sup>th</sup> Street and 6<sup>th</sup> Street from Stella Street to Mill Street. Ordinance 4173:

AN ORDINANCE TO AMEND, AND THEREAFTER REAFFIRM, ORDINANCE NO. 3675 AND ORDINANCE NO. 4157, EACH OF WHICH REVOKED A PORTION OF AN ALLEYWAY IN THE CITY OF WEST MONROE, LOUISIANA, BEING THAT ALLEYWAY LOCATED IN SQUARE/BLOCK 4 OF T. E. FLOURNOY'S FIRST ADDITION TO THE CITY OF WEST MONROE, LOUISIANA, AS PER PLAT OF RECORD IN PLAT BOOK 1, PAGE 21, RECORDS OF OUACHITA PARISH, LOUISIANA, BOUNDED ON THE NORTH BY THE SOUTHERLY RIGHT-OF-WAY LINE OF STELLA STREET, BOUNDED ON THE SOUTH BY THE NORTHERLY RIGHT-OF-WAY LINE OF MILL STREET, BOUNDED ON THE EAST BY THE WESTERLY BOUNDARY LINES OF LOTS 1 THROUGH 7 AND ON THE WEST BY THE EASTERLY BOUNDARY LINES OF LOTS 8 THROUGH 14, ALL IN SQUARE/BLOCK 4 OF T. E. FLOURNOY'S FIRST ADDITION TO THE CITY OF WEST MONROE, LOUISIANA, BUT EXCEPTING FROM THE REVOCATION AND RESERVING TO THE CITY ANY AND ALL RIGHTS-OF-WAY, EASEMENTS, SERVITUDES AND SIMILAR RIGHTS OF RECORD OR OF USE FOR THE INSTALLATION, REPAIR AND MAINTENANCE OF UTILITIES AND UTILITY SERVICES, OF WHATEVER TYPE OR NATURE, WHETHER OWNED OR MAINTAINED BY THE CITY OR OWNED, UTILIZED OR MAINTAINED BY OTHERS PURSUANT TO CITY FRANCHISE; AND OTHERWISE PROVIDING WITH RESPECT THERETO.

There was a motion by Mrs. Pearson, seconded by Mr. Bennett and unanimously carried to authorize the City Clerk to advertise for bids:


- a. New Pavilion at Kiroli Park

There being no further business, there was a motion by Mrs. Pearson, seconded by Mr. Brian and unanimously carried to adjourn.
