1. Motion to approve minutes of the September 9, 2014 regular Council meeting.
2. Motion to approve payment of the September, 2014 billings, subject to audit by the Finance Committee.
3. Ordinance to declare certain movable property (scrap metal) as surplus, and to be sold to Arkla Recycling (brass) and Monroe Iron & Metal Co., Inc. (iron). **(introduced in September)**
4. Ordinance to declare certain movable property (used cars) as surplus, and to be sold to Mickey's Used Cars (Marshal's office).**(introduced in September)**
5. Ordinance to amend Sec. 12-5021 of the Code of Ordinances to add preparation of low-risk foods to the listing of allowable home occupations. (Received a favorable review from the Planning Commission)
6. Resolution in support of Constitutional Amendment 3 and Constitutional Amendment 10, to authorize cooperative endeavor agreement to assist municipalities in administering property tax sales and assist the fight against blighted property.
7. Ordinance to enact Sec. 7-1004 of the Code of Ordinances, to grant authority for Mayor to accept the dedication or other transfers of servitudes, rights-of-ways, and/or easements on behalf of the City for purposes of installation, construction, operation, maintenance, repair and replacement of drainage, water and/or sewer facilities and improvements.
8. Ordinance to amend Sec. 9-1003 and Sec. 9-1005 of the Code of Ordinances, to clarify the authority of the police chief concerning certain traffic laws and provisions.
9. Ordinance to enact subsection 12-2005(f) and amend Sec. 12-4007.1 of the Code of Ordinances, both relating to drainage, traffic and other review prior to institution of subdivision approval or building construction.
10. Ordinance to enact Sec. 2-6004 of the Code of Ordinances, relative to appeals from decisions of the West Monroe Municipal Planning Commission.
11. Ordinance to amend subsection 8-1012(i), to add grates, drains, channels and other stormwater drainage system components to those items where it is unlawful to dispose of certain materials.
12. Resolution of endorsement of participation in the Louisiana Enterprise Zone Program for Affinity Health Group, LLC (Don Allison, contact).
