

MINUTES OF THE REGULAR MEETING
OF THE
WEST MONROE CITY COUNCIL

November 11, 2014

There was a regular meeting of the West Monroe City Council held on Tuesday, November 11, 2014, at 7:00 p.m. in the Council Chambers of the West Monroe City Hall.

Those present were Mayor Dave Norris, Aldermen James Bennett, James Brian and Thomas Hamilton, Alderwomen Alice Pearson and Staci Albritton-Mitchell.

The invocation was offered by Jerry Edmondson.

There was a motion by Mrs. Pearson, seconded by Mr. Bennett and unanimously carried to approve the minutes of the October 14, 2014 Regular Council Meeting.

There was a motion by Mrs. Pearson, seconded by Mr. Bennett and unanimously carried to approve payment of the October 2014 billings, subject to audit by the Finance Committee.

There was a motion by Mrs. Mitchell, seconded by Mrs. Pearson and unanimously carried to introduce an ordinance to declare certain movable property as surplus, and to be sold to various buyers (Utility Complex vehicles). Ordinance 4228:

Introduce AN ORDINANCE AUTHORIZING THE CITY OF WEST MONROE, LOUISIANA TO SELL CERTAIN DESCRIBED MOVABLE PROPERTY WHICH IS NOT NEEDED FOR ANY PUBLIC PURPOSE BY THE CITY OF WEST MONROE, LOUISIANA TO VARIOUS NAMED PURCHASERS, AND OTHERWISE PROVIDING WITH RESPECT THERETO.

There was a motion by Mrs. Pearson, seconded by Mrs. Mitchell and unanimously carried to approve an ordinance to authorize Cooperative Endeavor Agreement with Northeast Louisiana Master Gardeners Association, Inc. (area for greenhouse). Ordinance 4229:

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A COOPERATIVE ENDEAVOR AGREEMENT WITH THE NORTHEAST LOUISIANA MASTER GARDENERS ASSOCIATION, INC., AND OTHERWISE PROVIDING WITH RESPECT THERETO.

There was a motion by Mrs. Pearson, seconded by Mr. Bennett and unanimously carried to authorize City Clerk to purchase a fire truck (pumper truck) from the State of Louisiana Procurement List.

There being no further business, there was a motion by Mrs. Pearson, seconded by Mr. Hamilton and unanimously carried to adjourn.
